The Role

The University of Chicago Crime Lab and Education Lab is seeking a Project Associate with strong project management and data analysis skills. This position requires an individual who is able to work as part of small research teams running multiple projects concurrently. The position offers the opportunity to work directly with leading social policy researchers at the University of Chicago and government agency staff, as well as an experienced team of analysts, data scientists, administrative staff, and project managers.

Responsibilities

- Assists with the coordination of research activities, communications with partner agencies, and managing project deliverables
- Assists in writing grant proposals and preparing presentations targeting both policymakers and academic audiences

- Writes human subjects permission protocols and amendments for IRB permission, and obtains other research permits as needed
- Documents discussions and research activities with detailed notes and project logs
- Conducts thorough and critical reviews of relevant literature
- Assists with data collection, management, randomization, and analysis including cleaning and assembling the files for data analysis, and conducts field research as needed
- Prepares sections of research results, including proofing, formatting and creating tables and graphs
- Performs other related work as needed

Education

- Bachelor's degree in economics, statistics, public policy, or other relevant field required.

Experience

- Some relevant research experience required; experienced gained in school counts towards requirement

In addition, though none of the following are required for the position, candidates are encouraged to highlight experience in the following areas:

- Experience working on field experiments
- Experience working on large projects with multiple stakeholders

Competencies

- Strong and demonstrated interest in social policy preferred
- Knowledge and understanding of criminal justice and/or education policy literature strong preferred
- Demonstrated leadership skills preferred
- Evidence of effective communication skills – including interpersonal, oral, and written preferred.
- Ability to manage multiple projects simultaneously and meet tight deadlines preferred
- Demonstrated ability to work independently and to collaborate with others – both on internal teams and with external partners – preferred
- Ability to work discretely with sensitive and confidential data preferred
- Microsoft Word, Excel, and PowerPoint skills preferred
